ACTIVITIES AND ANNIVERSARIES
SUB-COMMITTEE

1. All decisions and viewpoints discussed by The Activity Sub-Committee should be governed by the 12 Traditions and 12 Concepts of NA.
2. The Activity and Anniversaries Sub-Committee can form Ad HOC committees for a specific function. After specific function is complete the committee will be disbursed.
3. Any funds collected by Activities or Groups, for the sole purpose of helping the Activity Committee to further its primary purpose, goes directly to that Sub-Committee until the end of the term. An oral or printed report of all collected funds will be given to the CFRANA after each event. **(Treasurer's Report ???)**
4. All funds should be counted by two (2) people to ensure accountability of funds.
5. Any dealings with vendors for merchandise should be handled by the Activity Chair or Merchandising Chair.
6. All decisions made by or for Area Activities Sub-Committee – there should be a prayer by all present – before making a final decision.
7. Any funds donated to the Activities Sub-Committee should be clearly stated at the time of donation. A receipt will be given at the time of donation.

8. The Activities & Anniversaries Sub-Committee can form an AD HOC Committee specifically for a function, and will be disbursed at the end of the function.
9. When a Committee member has a question regarding their position they should feel free to seek advice from more experienced people who have served in that position. Phone numbers will be provided for convenience.

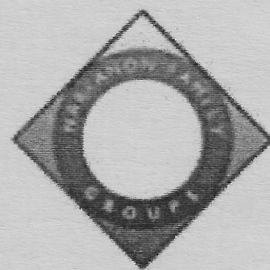
